ANS: C

The duties performed by the patient care technician do not constitute the practice of medicine. Diagnosing the patient is considered practicing medicine. The PCT may perform urine pregnancy testing, draw blood for laboratories, and perform finger-stick glucose testing.

ANS: A

The PCT is not expected to read and interpret x-rays. The clinical duties that patient care technicians perform vary according to the healthcare institution and state. They assist with or perform basic testing procedures and are usually proficient in phlebotomy. Patient care technicians are trained in first aid skills and cardiopulmonary resuscitation. They assist in minor surgical procedures.

ANS: B
