The best response is that ethics is more concerned with the "why" of behavior. Ethics are concerned with the basis of the action rather than whether the action is right or wrong, good or bad.

ANS: B

The nurse has been placed in a situation initially causing moral distress and is struggling with determining the ethically appropriate action to take. Moral courage is the freedom to advocate for oneself, patients, and peers. Autonomy is an ethical principle. Moral doubt is not part of the American Association of Critical-Care Nurses (AACN) framework *The 4A's to Rise Above Moral Distress*.

Patients and families must have all the information about a certain situation to make an autonomous decision that is best for them. They have the right to determine what is done to or for them without coercion or undue interference from others. Autonomy is the foundation of the legal and ethical requirement of informed consent and includes the right of patients with decision-making capacity to refuse some or all treatments.

Confidentiality of patient information and privacy in patient interactions must be protected and honored by health care providers out of respect for persons. Confidentiality is a right involving the sharing of patient information with only those involved in the patient's care. Privacy includes confidentiality but goes further to include the right to privacy of person and personal space, such as ensuring that a patient is adequately covered during a procedure. Truth, reflection, sovereignty, justice, beneficence, and nonmaleficence are not part of respect for persons.

The *ANA Code of Ethics for Nurses* provides the major source of ethical guidance for the nursing profession. It provides a framework for the nurse to follow in ethical decision making and provides society with a set of expectations of the nursing profession. The *ANA Code of Ethics for Nurses* is not written into nursing regulations or state or federal laws. However, the document is considered part of nursing professional standards.

Generally, the standard for negligence is failing to act as a reasonably prudent person would under the same circumstances or acting in a way a reasonably prudent person would not act under the same circumstances.

9. A patient is admitted with chest pain with evidence of elevated ST segments. The nurse bases the plan of care on the diagnosis of pneumonia. What type of malpractice may be present?

ANS: B

Basing nursing care on an erroneous diagnosis is a failure in planning. Standards of care include *assessment*, the collection of relevant data pertinent to the patient's health or situation; *diagnosis*, analysis of the assessment data in determining diagnosis and care issues; *implementation*, coordinating care delivery and plan and using strategies to promote health and a safe environment; and *evaluation*, evaluation of the progress of the patient toward attaining outcomes.

ANS: A

Injury resulting from the failure to meet an ordinary duty or standard of care is negligence. Assault and battery are examples of intentional acts. Malfeasance is intentional conduct that is wrongful or unlawful, especially by officials or public employees and does not apply to professional malpractice.

ANS: D

Nurses must appropriately notify practitioner of situations warranting treatment actions. Furthermore, the full no-code, do-not-resuscitate order does not exclude this patient from receiving treatment to correct the critical laboratory value. Failure to take appropriate action in cases involving acutely and critically ill patients has included not only practitioner-notification issues but also failure to follow practitioner orders, failure to properly treat, and failure to appropriately administer medication.

ANS: C

Nurses have a duty to preserve patient privacy, and failure to do so is a breach of patient confidentiality and failure to preserve patient privacy. Nurses should also refrain from having discussions about specific patients with anyone except other health care professionals involved in the care of the patient. When discussing specific patients with other health care professionals, it is imperative that patient-specific discussions occur in nonpublic settings. Discussions about specific patients are never appropriate in public areas such as elevators, cafeterias, gift shops, and parking lots.

Nurses have a duty to assess and analyze the care required by each patient they care for. Failure to do so puts the nurse at risk for negligence related to failure to assess the patient's needs.

The nurse has a duty to act as a patient advocate, in this case by holding the preoperative sedation until the practitioner and the patient can speak and the patient is satisfied that she has the necessary information to make this decision.

State Boards of Nursing (SBONs) maintain expectations for and limits of nursing practice in each state through the licensure of nurses and also through challenges to non-nurses engaged in professional activities that intrude upon the nursing scope of practice.

1. Which situations are at risk for becoming an ethical dilemma? (*Select all that apply.*)

ANS: A, C, E

Early indicators for an ethical dilemma include signs of patient suffering (prolonged, unrelieved pain), signs of unrealistic expectations (unwavering belief in patient recovery), signs of moral distress (believe treatment not helpful, causes suffering), signs of conflict (disagreement, different opinions), signs of poor communication (avoidance of end of life and other difficult topics), and signs of ethics violations (disrespect for autonomy, disregard of right to information). A practitioner recommending additional tests and health care team members discussing palliative care with a patient are not unusual situations and normally do not lead to ethical issues.

The person bringing the lawsuit (plaintiff) must prove the elements of negligence. In the health care context, the patient or family bringing the lawsuit must prove that the nurses had a duty to care for the patient, the nurses breached that duty by deviating from the standard of care, the breach caused harm to the patient that would not have occurred in the absence of negligence, damages or the monetary value of the injury suffered. The acknowledgement that the patient's preferred care was not provided is not a required element of a negligence lawsuit.

Battery is any intentional act that brings about actual harmful or offensive contact with the plaintiff. Harmful means physical harm, whereas offensive means contact that a reasonable person would consider offensive under the circumstances. Battery occurs if the patient is touched in an unauthorized manner. Assault occurs if the patient fears harmful or offensive touching. Assault may be alleged if the patient was aware that they were going to be touched in a manner not authorized by informed consent. Threatening to punch a patient who refuses to stay in bed and threatening to restrain a patient for not calling for help to get out of bed are examples of assault.
