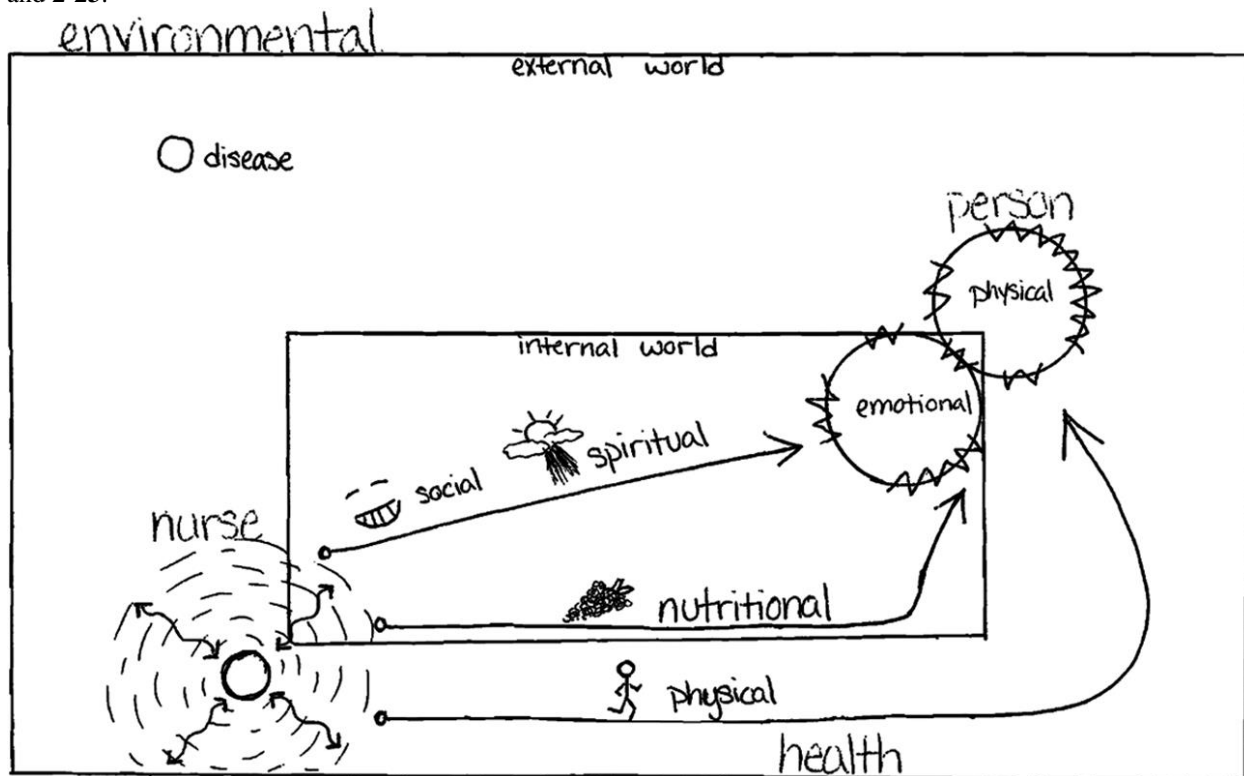


Figure 2-22 Student conceptual model.

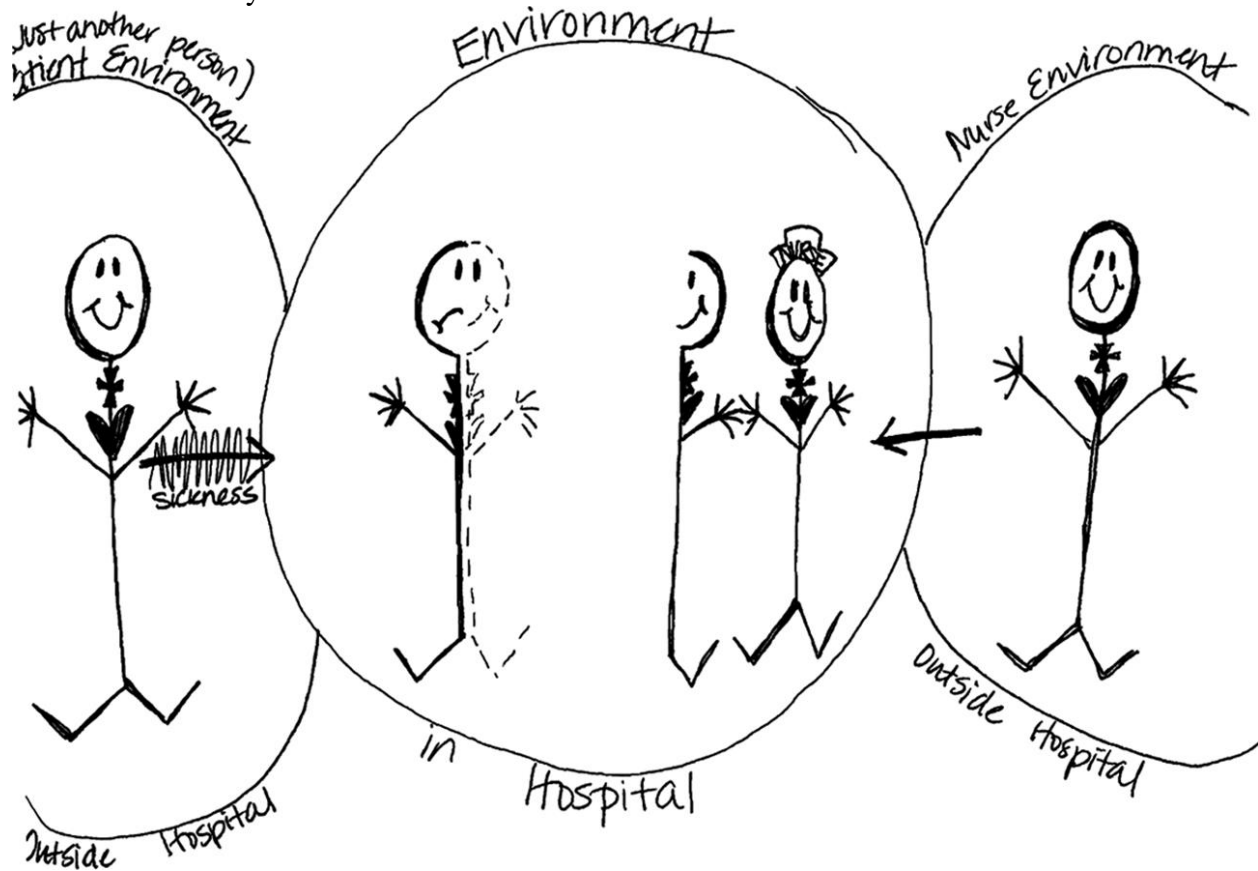


Figure 2-23 Student conceptual model.
